HKCS Limited will endeavor to help exhibitors apply for the said "Temporary Working Visa" but if the application is unsuccessful due to any reason or an application is not made then HKCS Limited reserves the right to employ a local helper for three days at the expense of the exhibitors.

Alternatively, the exhibitor may employ a valid local helper themselves to conduct retail sales activities and thus the responsibility of checking the validity to work in Hong Kong will lie with the exhibitors.
