Terms & Conditions 條款與細則 – Exhibitor Application 展商申請

Working Visa Requirement for Non-Hong Kong Residents

- Exhibition representatives who do not ordinarily reside in Hong Kong must obtain a Temporary Working Visa if they intend to engage in retail sales during the event.
- If the exhibitor's activities are limited to promotion and do not involve retail transactions, a work permit is not required.
- HKCS will endeavor to assist exhibitors in applying for the Temporary Working Visa, but reserves all rights if the application is unsuccessful.
- If the application is unsuccessful for any reason, or if no application is made, HKCS reserves the right to employ a local helper for three days at the exhibitor's expense.

簽證要求

- 所有非香港居民之參展商代表，如欲在展覽會公眾開放期間從事零售活動，必須依法申請「香港臨時工作簽證」。
- 若參展商的活動僅限於業務推廣而不涉及零售，則毋須申請工作簽證。
- 香港國際錢幣聯合展銷會可提供申請臨時工作簽證的協助，但如果工作簽證申請失敗，HKCS保留權利。
- 若簽證申請因任何原因未能成功，或參展商未有提出申請，本公司有權代為聘用本地工作人員三天，費用由參展商承擔。

Employment of Local Helpers

- Exhibitors may alternatively employ a valid local helper themselves to conduct retail sales. In such cases, the exhibitor bears full responsibility for verifying the helper's legal eligibility to work in Hong Kong.

聘用本地工作人員

- 參展商亦可選擇自行聘用合法的本地工作人員或代表從事零售活動。在此情況下，參展商須自行負責核實該工作人員在香港的合法工作資格。

Reminder: Non-Hong Kong residents engaging in retail activities must either obtain a Temporary Working Visa or employ a qualified local helper.

提示：非香港居民從事零售活動必須取得臨時工作簽證或僱用合法的本地工作人員。

Counterfeit Sales: Selling counterfeit items at the HKCS is not tolerated. If any report is verified, the organisers will immediately revoke the exhibitor's or individual's exhibition rights.

出售贗品：香港國際錢幣聯合展銷會場內禁止出售任何偽品錢幣。如有發現，大會將即時取消參展單位或個人的參展資格。

Payment Terms & Conditions

- Full payment must be made by the end of the show to qualify for early bird prices.
- No tables will be reserved unless a deposit of at least USD \$500 is made and the balance paid within three months. Otherwise, the deposit will be forfeited.
